**AB 2223: Legalized
Infanticide**

This is the infanticide bill. Yes. Seriously.

**SB 1142: All-Expense-Paid
Abortion Tourism**

This bill funds the physical and online infrastructure necessary to bring women seeking abortions from other states to California. And everything's FREE - airfare, bus, hotel, insurance arrangements, reimbursement for lost wages and even childcare so mom can get a taxpayer funded abortion.

**SB 1375: Eliminates
Abortion Safety Standards**

Eliminates medical standardized procedures and doctor oversight of abortion providers. Expands who can perform abortions in the state and where they can do it.

SB 1245: More LA Abortions

Uses tax money to fund a "pilot" program to expand access to more abortions in Los Angeles County, the hub for Abortion Tourism. More than a third of all abortions in the state already happen in LAC.

AB 2586: Defunds Pro-life "Fake Clinics"

Funds abortion clinics and targets the pro-life competition for elimination, calling pro-life clinics "fake."

AB 1918: Abortion Scholarships

Taxpayer funds will fund scholarships for medical students -- but only those who will perform abortions, especially in "underserved areas."

AB 1940: School-based Health Centers

Taxpayers will fund "school-based health centers" in or near public and private schools. Unless amended, health services can include abortions - for elementary and high school girls.

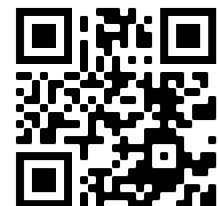
